OBJECTIVE

The objective of this Memorandum of Understanding is to establish the foundations of a partnership between the Asociación de Colegios IB del Perú (ASCIBP), and the TOEFL iBT® test. These aforementioned tests are designed and offered by ETS.



RESPONSIBILITIES

Asociación de Colegios IB del Perú (ASCIBP) to include:

- a) Socialize the importance of using the TOEFL IBT test in IB schools in high school members of ASCIBP.
- b) Organize with the TOEFL program, free training, counseling, and coaching offered by ETS.
- c) Provide support for the presentations and training by sending invitations, and offering the necessary conditions for the training.
- d) Promote the TOEFL iBT test on the ASCIBP website and brochures in accordance with ETS guidelines.

License and Treatment of Intellectual Property.

ETS grants to ASCIBP a limited, non-exclusive, non-transferable, non-sublicensable License to use the TOEFL Word Mark and Logo as needed to fulfill its obligations as set forth in the Agreement. ASCIBP represents warrants to adhere to Guidelines for Use of ETS World Marks, Trade Name, and Logos, as attached to this Agreement as Exhibit 1.

ASCIBP shall request prior written approval from ETS before distributing ETS-branded and/or ETS-copyrighted materials on any social media, mobile app, file-sharing platform, third-party website, or any other medium not specified in this Agreement.

TOEFL services include:

- TOEFL iBT skill-based workshops at the request of ASCIBP to service both university and high school students.
- b) Socialize the free TOEFL iBT Propell workshops for teachers with a B2 level who request support for their English language teaching and test preparation courses. These requests will be coordinated by ASCIBP and the High School interested in the workshops.
- Socialize webinars about TOEFL test registration, booking, and payment for students based on high school members of ASCIBP requests.

d) Provide discounts on the TOEFL iBT test:



TERMS AND TERMINATION

This Memorandum of Understanding will come into force on the date of its signature and will remain valid for a period of 1 (one) year. It may be terminated by mutual consent of both institutions. In this case, the terminating party will send a notification to the other, at no charge, 90 (ninety) days in advance, without prejudice to the agreed provisions in progress at the time of notification.

This Memorandum of Understanding can only be modified by means of an addendum with the consent and signature of both institutions.

FINAL PROVISIONS

This Memorandum of Understanding does not establish any exclusivity between ASCIBP, and Educational Testing Service - ETS, regardless of its nature. The purchase of the TOEFL iBT vouchers will occur through their respective contractual forms and the terms within the forms.

Upon agreeing to these terms, the two institutions signed the present Agreement in two (2) counterparts of equal form and content, in the presence of the witnesses named below.
